PART OF A FAMILY.

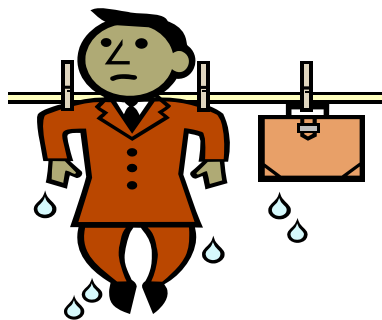

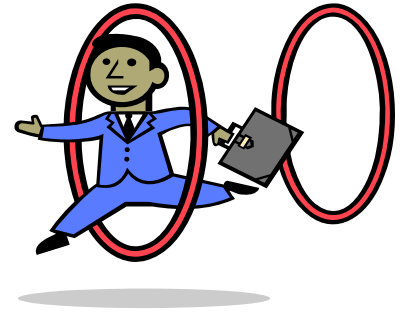
